



Friend Referral Policy (the “Policy”)

1. EuropeFX (the “Company”, “we” or “us”) gives its clients (“You”) the option to earn a cash reward by referring your friends to us (the “Reward”).
2. The Eligibility to receive the Reward shall apply only in regards to the first deposit(s) which shall be made by your friend(s) to his/ her / their account(s) (“Referred Client(s”).
3. The Reward shall be calculated as following:

Amount of Referred Client(s)	Reward per Referred Client
1-3	\$100
4-7	\$150
8 and above	\$200

4. Moreover, You shall receive the Reward only after the Referred Client(s) shall deposited funds to his/her/their trading account, and only after the Referred Client’s identification documents have been verified and the Referred Client(s) had completed the required portion of lots (the “Required Lots”).
5. The Required Lots shall be calculated as following: 0.2 lots multiplied by the amount of the Reward per each referral:

For example:

0.2 lot * \$200 Reward per referral = 40 Required Lots.

6. It is in the sole discretion of the Company to modify, amend or discontinue this Policy at any time.
7. the Company may, in its sole discretion, decline, cancel, or reverse the Reward or any portion of it, if such Reward was given to you:
 - i. by mistake; or
 - ii. pursuant to a referral that was made in bad faith; or
 - iii. pursuant to an act of fraud, misconduct, or abusive practices.
7. Eligibility to Participate:
 - i. At the time of participation in the Policy, you must hold a live trading account with us;
 - ii. The Policy shall not apply to affiliates and/or IB’s including their Sub IB’s and their clients.
8. The Required Lots shall not include the following transactions:
 - i. Hedging transaction(s) (i.e. buy one sell one). Such transaction shall be seen as one transaction;
 - ii. Transaction(s) which shall be closed within 180 seconds from their opening.
9. The Reward per referral shall not be awarded:
 - i. If Your account is stopped out before the Referred Client(s) complete the Required Lots;

- ii. If You withdraw all Your trading account balance, before the Referred Client(s) completes the Required Lots;
 - iii. If the Referred Client(s) withdrawal the trading account balance without trading;
 - iv. If the Referred Client(s) had not completed the Required Lots within two months, from first deposit date.
10. This policy shall not apply retroactively.
11. A joint account shall be considered as one Referred Client.
12. By the end of each month, the Company shall review the eligible accounts, in case of meeting the requirements of this Policy Your account shall be rewarded within five business days from first of the following month.
